A further deposit of 5% of the Purchase Price shall be paid within 120 days after the date of the preliminary agreement for sale and purchase or on completion, whichever is the earlier.

The “Stamp Duty Cash Rebate” shall be applied by the Vendor directly for payment of the ad valorem stamp duty payable on the relevant agreement for sale and purchase of the residential property to the Inland Revenue Department upon signing of the said agreement. If the actual stamp duty payable by the Purchaser is less than the maximum amount of the “Stamp Duty Cash Rebate”, the Vendor shall not be liable to pay to the Purchaser and the Purchaser shall not be entitled to receive the difference between the actual amount of ad valorem stamp duty paid to Inland Revenue Department and the maximum amount of the “Stamp Duty Cash Rebate”. If the ad valorem stamp duty payable is more than the maximum amount of “Stamp Duty Cash Rebate”, the difference between the ad valorem stamp duty assessed by the Inland Revenue Department and the maximum amount of “Stamp Duty Cash Rebate” shall be borne by the Purchaser. The “Stamp Duty Cash Rebate” is also subject to the terms and conditions of the relevant transaction documents.

Whether the application is approved or not is subject to the final decision of the Lender. This mortgage loan is subject to the following main terms and conditions: -

After the Vendor received such application and duly verified the information, the Vendor will apply the "Early Settlement Cash Rebate" as part payment of the balance of the Purchase Price directly.

In case of any dispute, the decision of the Vendor shall be final. However, this “Extended Defect Maintenance Offer” is personal to the Purchaser and is to be enjoyed by the Purchaser only. This “Extended Defect Maintenance Offer” is non-assignable, non-transferable and subject to other terms and conditions.
